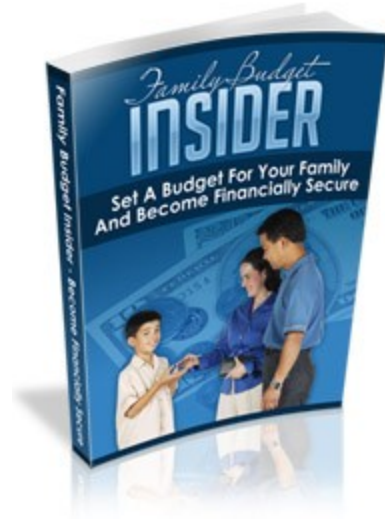

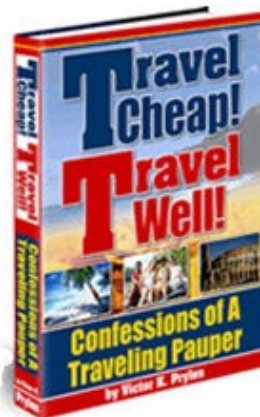

it is easy to implement a plan for change. Saving money isn't difficult and doesn't require expensive gadgets. All you need is to find out where your money is going which will require a little of your time.

Set Up a Family Budget for Every Member of the Family

One thing that parents often hear as their child nears adolescence is "Can I have some money?" Children want things much the same way adults do. Placing a bit of money aside when you set a family budget, for your child is a good idea, but it's important to make certain that they work for that money. Giving a child everything they desire is lovely in theory but it doesn't teach them that a budget is essential to financial success.

Teach Your Children The Value

- **Withdraw as much cash as you'll need for the week.** Instead of taking \$20 out 5 times in the span of a week, withdraw \$100 once a week. By doing that you've already saved four ATM transactions for the month. This could keep you under the minimum and also not paying extra fees for usage.
